Creating and Evaluating Interdisciplinary

Centers and Institutes

Policy Statement

Interdisciplinary c<u>C</u>enters <u>or institutes</u> may be created <u>at the University of</u> <u>Minnesota</u> to support and advance <u>strategic</u> research, education, or public engagement initiatives.

In general, the distinction between the use of the term center or institute is based on the size, scope, and complexity of the initiative. Refer to the Definitions section for detail.

<u>Centers or institutes will be categorized based on their strategic intent and</u> <u>scope, and the breadth of their membership. These categories are described</u> <u>below:There are three categories of interdisciplinary centers and/or institutes</u> <u>at the University:</u>

- University-wide <u>Center or Institute</u>: <u>Center or institute</u> includes members from different colleges and/or campuses; is aligned with the University's strategic priorities; must be authorized by the <u>President, the Executive Vice President and Provost, and the Vice President for</u> <u>Research and Innovation</u><u>President and Executive Vice President and</u> <u>Provost; or by the President and the Vice President for Research and Innovation</u>; and reports to the Executive Vice President, or one of the Vice Presidents, or designee.
- Intercollegiate <u>Center or Institute</u>: <u>Center or institute</u> includes members from different colleges and/or campuses; is aligned with the

school's strategic priorities; must be authorized jointly by the deans of the colleges; and reports jointly to the deans, or designee(s).

 Collegiate <u>Center or Institute</u>: <u>Center or institute</u> includes mostly members from the same college, although the work could be of an interdisciplinary nature; is aligned with the school's strategic priorities; must be authorized by the dean(s) of the colleges; and reports to the dean(s), or designee(s)

Procedure to Request New Center or Institute:

- University-wide: Please review the University-wide Centers:
 Establishing, Operating and Evaluating procedure for guidance. A
 University-wide center or institute may only be established by the
 President, the Executive Vice President and Provost, and the Vice
 President for Research and InnovationPresident, or the Executive Vice
 President and Provost, or the Vice President for Research and
 Innovation.
- <u>Center fIntercollegiate or Collegiate: Please see the Collegiate and Intercollegiate Centers: Establishing, Operating and Evaluating procedure for guidance. Faculty or staff seeking to create an intercollegiate or collegiate n interdisciplinary center or institute must follow -the policies established by their colleges. They will submit a request to the appropriate senior leader (e.g., dean(s), vice president, provost, etc.) for approval. If approved, the dean(s) will then seek the appropriate executive approval(s) prior to establishing the center or institute beginning work (see applicable procedures for the appropriate type of center_or institute).</u>

Annual Reporting Requirements:

All center or institute directors (e.g., University-wide, intercollegiate, collegiate) must submit an annual report to the senior leader to whom they report. All centers or institutes are encouraged to follow the same guidelines for annual reports and established reviews. All center or institute directors must update information annually in the University's database of centers and institutes. Intercollegiate and Collegiate center or institute directors must submit an annual report to the senior leader to whom they report.

<u>GUIDANCE NEEDED for steps to establishe a University-wide center (as</u> done for intercollegiate/collegiate above)

University-wide <u>cCenter or iInstitute</u> directors must submit an annual report to the senior leader to whom they report. All other centers <u>or institutes</u> are encouraged to follow the same guidelines for annual reports and established reviews. All center <u>or institute</u> directors must update information annually in the <u>University's database of centers and institutes</u>.

Term and Renewal:

Authorization for University-wide, and intercollegiate, and collegiate centers or institutes is for a specified period of time, determined at the time the center or institute is established. Iimited period of time, e.g., 5-7 years, specified at the time the center is established. Prior to potential renewal, a formal review and assessment must be performed.

Reason for Policy

This policy <u>defines the purpose and process to establish a center or institute</u> in creates the administrative structure necessary to provide an environment supportive of interdisciplinary efforts and the strategic priorities of the University, its campuses, and collegiate units. <u>It delineates the different types</u> of centers and institutes and the review and approval processes required for each. Through this policy and the associated procedures (see below), uniform methods of creating, ensuring the quality <u>of</u>, and measuring the effectiveness of <u>interdisciplinary</u> centers and institutes are provided for all collegiate units and faculty <u>engaged in interdisciplinary research, teaching, and public</u> engagement. In addition, the policy delineates the different types of centers <u>and institutes</u> and the review and approval processes appropriate for each.

Definitions

<u>Center</u>

Centers are programs, consortia, or initiatives organized on a highly specific theme or topic, that are established to support and advance research, education, or public engagement and involve multi-departmental collaboration. They may involve faculty from within the same school or faculty from across different schools.

<u>Institute</u>

Institutes are large multidisciplinary programs established to support and advance research, education, or public engagement and involve multidepartmental collaboration.

Institutes are usually organized to conduct research with a broad mission, as well as offer educational programs. Most institutes involve faculty from multiple departments across different schools. An institute may include a number of centers or laboratories within it, and may also be involved in community outreach or clinical services.

University-wide Center or Institute

An entity authorized by the President, the Executive Vice President and Provost, and the Vice President for Research and InnovationPresident and Executive Vice President and Provost or Vice President for Research and Innovation to support and advance research, education, or public engagement initiatives aligned with key University strategic priorities.

Intercollegiate Center or Institute

An entity established to support and advance research, education, or public engagement that includes members from different colleges and/or campuses.

Collegiate Center or Institute

An entity established to support and advance research, education, or public engagement that includes mostly members from the same college, and from across numerous departments within the college.

Intercollegiate Center or Institute

An entity established to support and advance research, education, or public engagement that includes members from different colleges and/or campuses.

Interdisciplinary Center or Institute

An organizational unit within the University that is formed to promote interdisciplinary studies or initiatives. <u>Most These</u> centers <u>or institutes will be</u> <u>interdisciplinary</u>. <u>may also be known as consortia, institutes, initiatives,</u> <u>programs, etc. This policy uses the term "centers" or "institutes"</u> to refer to all of these alternatives.

University-wide Center or Institute

An entity authorized by the President and Executive Vice President to support and advance research, education, or public engagement initiatives aligned with key University strategic priorities.

Responsibilities

President

Authorize designation of University-wide Center.

Executive Vice President and Provost

Authorize designation of University-wide Center.

Vice President for Research and Innovation

Authorize designation of University-wide Center

Deans

Approve the creation of intercollegiate and collegiate centers<u>or institutes</u>; conduct periodic reviews of centers<u>and institutes</u> under their jurisdiction.

Faculty

Prepare <u>proposal</u>, <u>business plan</u>, <u>and other</u> documents to establish a center <u>or institute</u> and perform work of the <u>described</u>center.

Center Director

Follow operating guidelines for centers<u>and institutes</u>. Facilitate continuous progress toward the academic objectives cited in -the center's <u>or institute's</u> authorization request and demonstrate its ability to offer competitive or educational advantage. Document how it measurably contributes to the University's <u>or college's</u> strategic goals. Provide <u>an</u> annual update to <u>the</u> University's centers-and-institutes database<u>and to the senior leader to whom they report</u>.
